



IN DEEP

CONDITIONS OF ENTRY

Group Exhibition of artworks by members of Jervis Bay and Basin Arts Inc. for See Change Winter Arts Festival 2010

Date: 30th May to 27th June 2010

Gallery Space: Lady Denman Heritage Complex

Entry Requirements:

Artists must be members of JB and B Arts Inc. and 16 years or over
Exhibition space is limited so one [1] artwork only may be entered
or small grouped works classed as one [1] entry.

a. ARTWORKS

1. Entries in any style, any medium.
2. One entry only per artist.
3. All works to be fully labelled: artist's name, address, phone number, title of work, medium, price.
4. 2D works **must** be fitted with **D rings**.
5. 3D works to be a weight that can be easily lifted.
6. Non-refundable entry fee of \$15 per work [**cheques made out to full title 'Jervis Bay and Basin Arts Inc. - no initials'**].
7. Delivery and collection of works is the artist's responsibility.
8. Artists must give permission for works to be reproduced in whole or in part for publicity for Jervis Bay and Basin Arts Inc. and therefore waive copyright.
9. The Committee will try to hang all works but in some circumstances may have to select entries.

b. SALE OF WORKS

1. Sales will be recorded and receipted by Exhibition Minders [rostered Jervis Bay and Basin Arts Inc. Members].
2. Ideally sold works should be left until the end of the exhibition. However if purchaser is from out of town the work may be let go and replaced with a similarly sized work by the artist. **The artist must pay a \$15 entry fee for each replacement work.**
3. The artist has the responsibility for arranging for the purchaser to collect the work at the end of the exhibition, or to deliver work to the purchaser.
4. All sale money will be initially paid to Jervis Bay and Basin Arts Inc. The Treasurer will pay the artist the requisite sum minus 15% commission within a reasonable period after the close of the exhibition.

c. INSURANCE

1. For reasons of public liability/personal accident insurance all exhibitors must be **financial members** of Jervis Bay and Basin Arts Inc.
2. Insurance of the work is the responsibility of the artist. While all care will be taken, no responsibility will be accepted by the Committee.

d. VISITOR ENTRY FEES

1. The Exhibition will be open to the public from Sunday 30th May to 27th June 2010.
2. The Official Opening and the **In Deep** exhibition will be incorporated in the Opening of **The See Change Winter Arts Festival 2010** on Saturday 5 June 2010. An entry fee will be charged to visit the gallery throughout the day.
4. Exhibiting artists will be admitted free on presentation of a non-transferable pass issued by Jervis Bay And Basin Arts..

e. 'EXHIBITION MINDING' ROSTER

1. Jervis Bay and Basin Arts Inc. will provide Exhibition Minders from 10am to 4pm each day the exhibition is open .
2. **Each artist is required to "exhibition sit" for one or more 3 hour periods.** [Whether more than one sitting is required will depend on the number of entries received] You will be required to put your name on the roster, when you deliver your work.

f. ARTIST'S PROFILE

1. Artists should register their profile online at www.jervisbayarts.asn.au. We are attempting to collate a data base of artists' profiles to be used as required. Artists can update these from time to time.
